Foliar Feeding To supplement the efficacy of soil applied fertilizers.
Fertigation For application through drip or sprinkler irrigation systems.

MULTIFEED FLOWERGRO - Water Soluble Fertilizer (46) is recommended for use on established plants with higher potassium requirements, such as certain vegetable and field crops, and for nursery crops to achieve hardening and maintenance of vegetative growth.

RECOMMENDATIONS:

MULTIFEED FLOWERGRO – is a concentrated balanced water soluble fertilizer containing high potassium (K) specially designed for use in flower beds, pot plants, roses, shrubs and fruit trees.

MULTIFEED FLOWERGRO - is ideally suited for use during the flowering and fruiting stages when there is a high demand for potassium (K).

MULTIFEED FLOWERGRO – can be applied with other foliar spray fertilizers.

APPLICATION TABLE:

METHOD	RATE OF APPLICATION	RECOMMENDATION	
DRENCHING: (Mixer nozzles, watering cans)	10 g (2 measuring spoons) in 10 ℓ water (i.e. 100 g/100 ℓ) Average content of watering can is 10 to 12 ℓ	Drench the plant with the MULTIFEED FLOWERGRO solution. Ensure application is made only to moist soil.	
FERTIGATION: (All irrigation systems micro, drip, sprinkler)	DAILY: 250 – 500 g / 100 ℓ water WEEKLY: 1 000 g/1 000 ℓ water	Apply through irrigation daily or on a weekly basis. Calibrate fertilizer injector to deliver the required amount.	
FOLIAR SPRAY:	MIXING RATIO: 20 g (4 measuring spoons) in 5 ℓ (i.e. 40 g/10 ℓ)	TYPE	SOLUTION / 50 m²
		FLOWERS	5 ℓ
		ORNAMENTALS, SHRUBS	6 ℓ
		TREES	7 ℓ
		Apply every 7 - 10 days. Do not spray in hot, dry conditions. Spray after good rain or irrigation on dry foliage.	
NOTES: 1. A foliar spray is recommended only for use as a supplementary source of nutrients to a basic fertilizer programme. 2. Do not mix with lime sulphur or Bordeaux mixture.
