SECTION 4. FIRST AID MEASURES

Description of first aid measures:

In case of inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention if you feel unwell.

SECTION 5. FIRE -FIGHTING MEASURE

Extinguisher media:

Methods for containment and cleaning up:

For small spills: Sweep and contain spilled material, prevent dust formation. Collect in suitable and properly labelled containers.

For large spills: Remove all sources of flames and sparks, for dry spills, shovel up and sweep up with damp earth or sand or other suitable absorbents, taking care not to raise a dust cloud. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g., sand, earth, vermiculite or diatomaceous earth and place in well labelled container for disposal according to local regulations.
